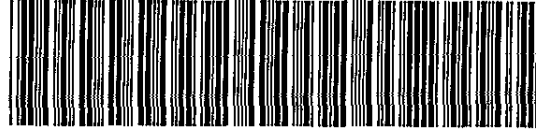



**ARTICLES OF ORGANIZATION OF
NOR-CAL ENTERPRISES, LLC**

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida sets forth the following:

ARTICLE I: NAME

The Name of the Limited Liability Company is: Nor-Cal Enterprises, LLC

ARTICLE II: ADDRESS

The Mailing Address of the Principal Office is: 9029 Copeland Road, Tampa, Florida 33637.

The Street Address of the Principal Office is the same.

ARTICLE III: DURATION
