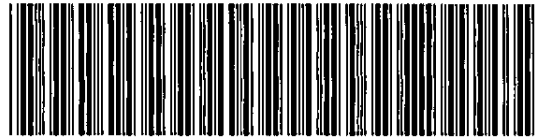

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I  
NAME**

The name of the Limited Liability Company shall be change from **YES TO YOGA, LLC**, to **THE FLORIDA YOGA HOLDING COMPANY, LLC** hereinafter "Company". The mailing address of the Company shall be **29056 Alessandria Circle, Bonita Springs, Florida 34135**. **ARTICLE II  
DURATION**

The general purpose for which the Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the members proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

**ARTICLE VI  
TERMINATION OF EXISTENCE (CONTINUITY OF LIFE)**




