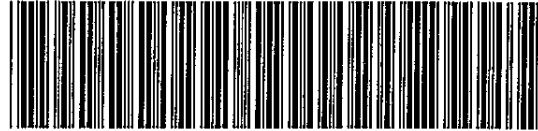

**ARTICLES OF ORGANIZATION  
OF

**A FLORIDA PROFESSIONAL LIMITED LIABILITY COMPANY**

The undersigned individual, being duly licensed to practice law in the State of Florida, for the purpose of forming a professional limited liability company for profit under Chapter 621 and Chapter 608 of the Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the professional limited liability company shall be the **LAW OFFICE OF ANTONETTE P. RUSSELL, L.C.**, hereinafter referred to as the ("Company").

**ARTICLE III -- PURPOSE**

The purpose for which the Professional Limited Liability Company is organized is to engage in the practice of law and all other activities incident thereto in compliance with applicable law.

**ARTICLE IV -- EFFECTIVE DATE**

The company shall have an effective date of February 5, 2004

**ARTICLE V -- DURATION**

The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles of organization.

**ARTICLE VI -- REGISTERED OFFICE AND AGENT**

**ARTICLE VII -- CAPITAL CONTRIBUTIONS**

The initial capital contribution of the members of the company shall be the cash amount of \$100.00 Dollar. Any capital contribution required by any additional members shall be determined by unanimous consent of the existing members at that time.

**ARTICLE VIII -- ADDITIONAL CAPITAL CONTRIBUTIONS**

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members at that time.

**ARTICLE IX -- ADMISSION OF NEW MEMBERS**

Except as set forth in the regulations, no additional members shall be admitted to the company except if they are an attorney licensed to practice law in Florida or any other jurisdiction and with the unanimous written consent of all the members of the company and on the terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all other members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

**ARTICLE X -- MEMBERS' RIGHT TO CONTINUE BUSINESS**

The remaining member or members of the company shall continue the business on the death, insanity, bankruptcy, retirement, resignation, expulsion or dissolution of a member or on the occurrence of any other event that terminates the continued membership of a member in the company.

**ARTICLE XI -- MANAGEMENT**

The company shall be managed by the members in accordance with regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
