**ARTICLES OF ORGANIZATION
FOR

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, hereby adopts the following Articles of Organization.

ARTICLE I

NAME

The name of the Limited Liability Company shall be: **SUPER YACHTPORTS, LLC**

ARTICLE II

ADDRESS

DURATION

**ARTICLE IV
MANAGEMENT**

The management of SUPER YACHTPORTS, LLC shall be vested pursuant to an Operating Agreement in the following Manager, who shall be appointed by the members. The name and street address of the initial manager is First Partners Corporation, a Florida corporation with offices located at 11300 U.S. Highway One, Suite 203, North Palm Beach, FL 33408.

**ARTICLE V
TREATMENT AS PARTNERSHIP**

SUPER YACHTPORTS, LLC is intended to be treated as a partnership for purposes of federal income taxation.

**ARTICLE VI
AMENDMENT OF REGULATIONS**

The power to adopt, alter, amend or repeal the Regulations, or Operating Agreement, of this Limited Liability Company shall be vested in the Managers of the Limited Liability Company.

**ARTICLE VII
TRANSFERABILITY OF MEMBER'S INTEREST**

The beneficial interest of a Member of this Limited Liability Company may be transferred or assigned to such extent and in the manner provided in the Operating Agreement. However, if all of the remaining Members of this Limited Liability Company do not approve of such proposed transfer or assignment by unanimous written consent, the transferee of the interest of such member shall have no right to participate in the management of the business and affairs of this Limited Liability Company or to become a Member. The transferee shall become an assignee only,

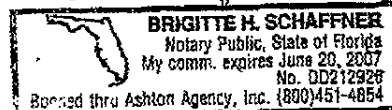

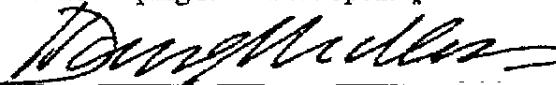
