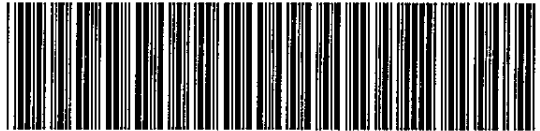

ARTICLE 1

The name of this company is: 9191 Oakland, LLC

ARTICLE 2

The mailing address and street address of the principal office of the Limited Liability Company is: 1800 N.W. 69th Avenue, Suite 201, Plantation, Florida 33313

ARTICLE 3

This company is organized under Florida Statute Chapter 608 for the purpose of transacting any or all lawful business permitted under the laws of the United States of America and under the laws of the State of Florida.

ARTICLE 4

The company is authorized to issue Certificates of Beneficial Interest with no-par value.

ARTICLE 5

The name and Florida street address of the initial registered office of this company is: Sidalco, Inc., 1800 N.W. 69th Avenue, Suite 201, Plantation, FL 33313.

ARTICLE 6

In a manner provided in the regulations of the company, additional members may be admitted to the company only upon the unanimous consent of current members, and only upon payment in full of an amount unanimously agreed to by the current members.

An interest of a member in the company may be transferred to assigned as provided in the operating agreement, however, unanimous written consent by all non-disposing members is required to approve the assignment or transfer, and until such approval is granted, the transferee does not have the right to participate in the affairs and business of the company or to become a member.

ARTICLE 7

The management of the company shall be vested in a manager or managers by annual election of the members in a manner prescribed by the regulations of the company. The initial manager shall be Sidalco, Inc., 1800 N.W. 69th Avenue, Suite 201, Plantation, Florida 33313. Sidalco, Inc. shall serve as managing member until a successor manager or managers is elected and qualified by the members.

ARTICLE 8

The members reserve the right to amend or repeal any provisions contained in these Articles of Organization or any amendment hereto. Any right conferred upon a member is subject to this reservation. The amendment shall be signed and sworn to by all members, and an amendment adding a new member shall be signed also by the new member to be added.

ARTICLE 9

The power to adopt, alter, amend or repeal the regulations of the company shall be vested in the managers of the company.

ARTICLE 10

The offices, responsibilities and powers accorded to the manager by the members is set out in the operating agreement of the company.
