The name of the Company is AMAYSING PROPERTIES, L.L.C.

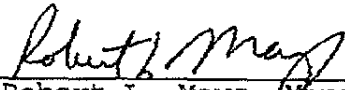
ARTICLE II - RESOLUTION TO DISSOLVE
