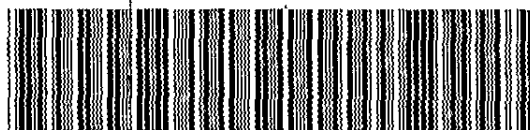


FIRST: The Articles of Organization were filed on February 20, 2004 and assigned document number L04000013863
