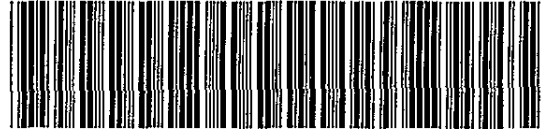

**ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION OF

3. Article I of the Articles of Organization of the Corporation shall be amended to read as follows:


"ARTICLE I - NAME
