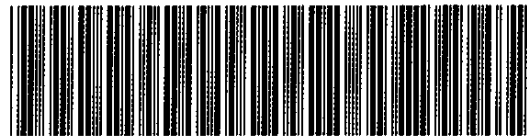

**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF
SUWANNEE RIVER LANDSCAPING, LLC**

TO: Department of State

Pursuant to the provisions in Section 608.411 of the Florida Statutes, the undersigned limited liability company hereby adopts the following Articles of Amendment to its Articles of Organization pursuant to the unanimous consent of its members:

1. The Articles of Organization shall be amended to read as follows:

**AMENDED AND RESTATED ARTICLES OF ORGANIZATION

The undersigned members adopt the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act (the "Act").

**ARTICLE I
NAME OF COMPANY**

The name of the limited liability company is Suwannee River Landscaping, LLC (the "Company").

**ARTICLE II
PERIOD OF DURATION**

The Company shall terminate on February 20, 2103.

**ARTICLE III
REGISTERED OFFICE AND AGENT**

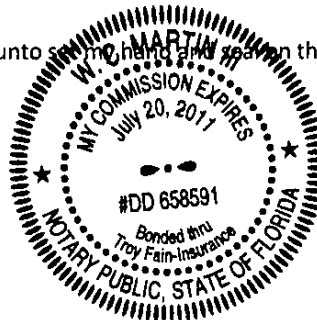


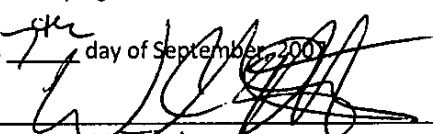
