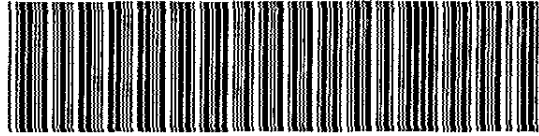

**ARTICLES OF ORGANIZATION
OF

ARTICLE 6.0

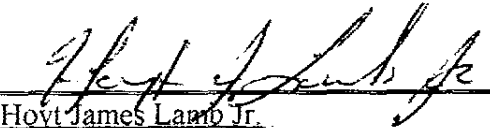

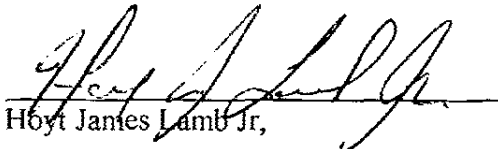
