**ARTICLES OF ORGANIZATION
OF

ARTICLE I

Name, Mailing Address and Purpose of Organization

Management of the Company


The Company shall be managed by one or more managers, who shall be elected annually by the Members in the manner set forth in the Company's Operating Agreement.




