

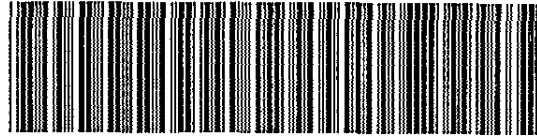

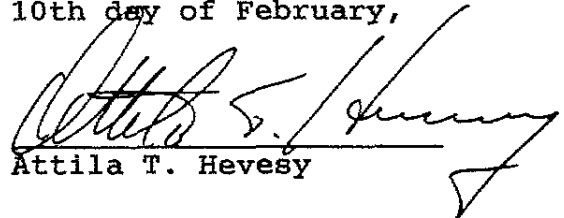
ARTICLE VI
