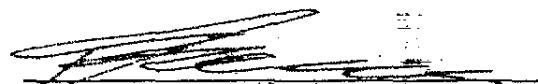
These Articles of Organization shall take effect and the Limited Liability Company's existence shall commence on February 23, 2004.

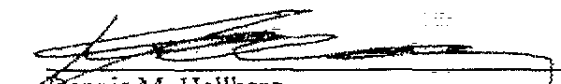
