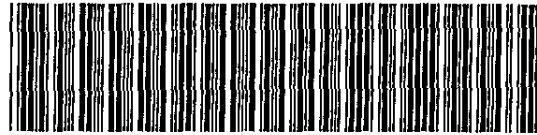

**ARTICLE 1 - NAME**

The name of this Limited Liability Company is **OPC, L.L.C.**

**ARTICLE II - DURATION**
