# ARTICLES OF ORGANIZATION of

## Cierra Development, LLC

The undersigned certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. #### ARTICLE III EXERCISE OF POWERS
