ARTICLES OF ORGANIZATION OF CULFSTREAM GARDENS, LLC

- 1. NAME. The name of this limited liability company is GULFSTREAM GARDENS, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
- 2. PLACE OF BUSINESS. The street address of the Company's principal office is 601: Bayshore Boulevard, Suite 650, Tampa, Florida 33606.

- 4. MANAGEMENT OF THE COMPANY. - 5. OPERATING AGREEMENT. The managers shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
