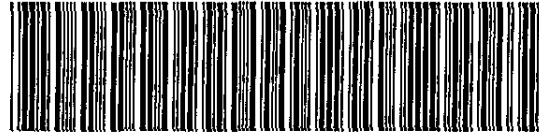

Pursuant to Chapter 608 of the Florida Statutes, the undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I: The name of the Limited Liability Company is "KOBALT, L.L.C.".

ARTICLE II: This Limited Liability Company shall have perpetual existence commencing on the date of filing of these Articles of Organization with the Secretary of State of the State of Florida. The Company is organized for any legal and lawful purpose for which a Limited Liability Company may be organized pursuant to chapter 608, Florida Statutes, as the same may be amended from time to time. 
ARTICLE VI: The members have the right to admit additional members upon written consent by each member as to the admission of an additional member.
