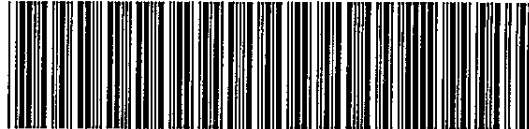



Article I. Name: The name of the Limited Liability Company is **C C JACK INVESTMENTS, LLC**.




