Articles of Organization
Of

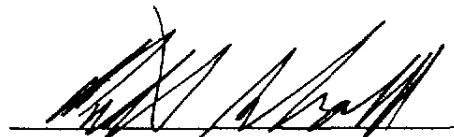
ARTICLE III: Address.

The Company shall initially be managed by the following two persons.

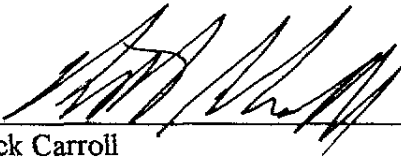

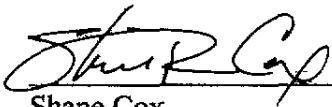
