ARTICLE IV

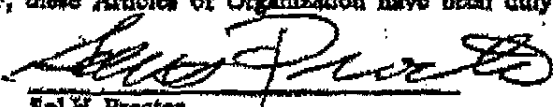

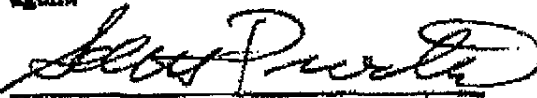
