FIRST: The name of the Limited Liability Company is:

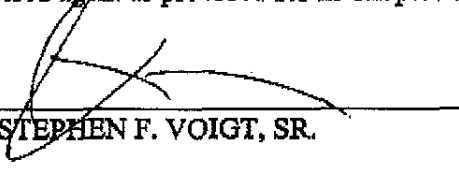
A & C MANAGEMENT, LLC
