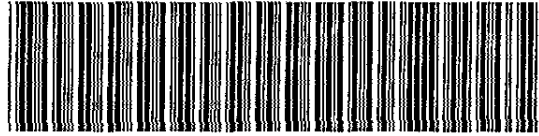

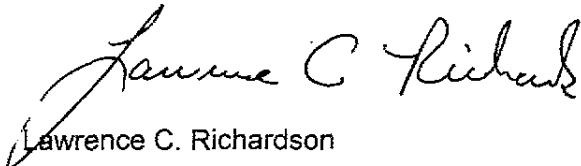

The name of the Limited Liability Company is Lawrence C. Richardson LLC (the "Company").

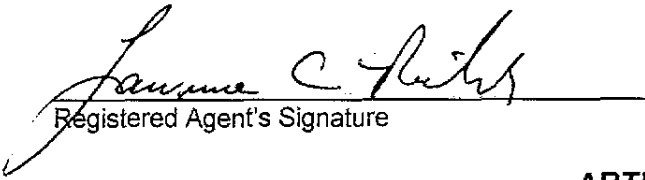

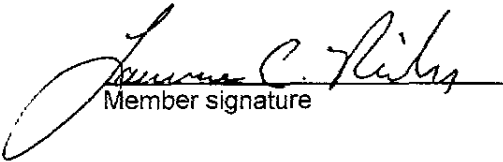
