Pursuant to Section 608.441 Florida Statutes, the undersigned Limited Liability Company adopts these Articles of Dissolution.

ARTICLE I

Name; Release of Name

The name of the Limited Liability Company is Dixie Thompson Wholesale. The Limited Liability Company hereby waives any rights or claims to the name "Dixie Thompson Wholesale", and releases the use of said name upon filing of these Articles of Dissolution.

ARTICLE II

Authorization

Written notice will be given to all known claimants after the effective date of the dissolution. The notice will provide a reasonable description of the claim that may be asserted, whether or not the claim is admitted, and where the claim may be sent.

There are no suits pending against the Limited Liability Company in any court.


ARTICLE VI

Plan of Distribution of Assets


Upon the Effective Date of these Articles of Dissolution or as soon as practicable thereafter, the assets of the Limited Liability Company shall be applied and distributed as follows:
