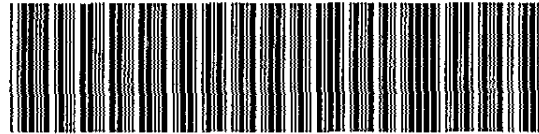

ARTICLE I

Name




