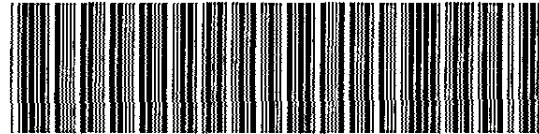

The name of the limited liability company is BEACH TRAIL DEVELOPMENT, LLC.


