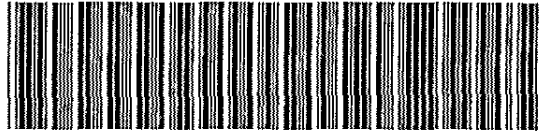

ARTICLE VII- Member's Right to Continue Business:

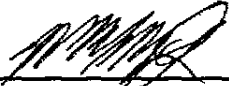
