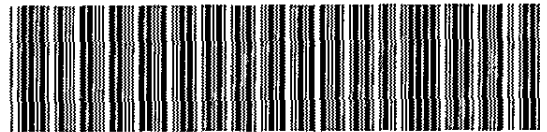

ARTICLES OF ORGANIZATION
OF
BLUE HORIZON CONDOMINIUM DEVELOPERS, LLC

The undersigned members, for the purpose of forming a Limited Liability Company for profit under the laws of the State of Florida, hereby adopt the following Articles of Organization:

ARTICLE I - NAME

The name of this Limited Liability Company is:

BLUE HORIZON CONDOMINIUM DEVELOPERS, LLC

ARTICLE II - TERM OF EXISTENCE

This Limited Liability Company is to exist perpetually.

ARTICLE III - PURPOSES

The purposes of this Limited Liability Company are to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - PRINCIPAL OFFICE

ARTICLE VII - VOTING

All members shall be entitled to vote on matters relating to the business operations of this Limited Liability Company. Each member shall have one vote for each membership unit owned.

MEMBERSHIP UNITS

The number of membership units that this Limited Liability Company is authorized to have outstanding at any one time is TEN THOUSAND (10,000) voting units having a no par value.

ARTICLE VIII - ADDITIONAL MEMBERS

ARTICLE IX - CONTINUATION OF BUSINESS OPERATIONS

In the event of the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member, the remaining members shall continue the business operations of this Limited Liability Company.
