THESE ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF ANDERSON TRIM CARPENTRY, LLC, Document No. L04000015955, are made pursuant to F.S. 608.411 Florida Statutes. The undersigned would show as follows:

1. The name of the Limited Liability Company is ANDERSON TRIM CARPENTRY, LLC.
2. The date of filing of the Articles of Organization was March 1, 2004.
3. Article V of the Articles of Organization is deleted in its entirety, and the following is substituted therefor:


"ARTICLE V

The Company shall be a manager-managed company and shall be managed by David W. Anderson, Craig A. Schneider and William H. Hammond. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with the law or these Articles of Organization. The general purpose of the Company is to perform any lawful business within or without the State of Florida."
