**ARTICLES OF AMENDMENT TO  
ARTICLES OF ORGANIZATION  
OF NE-CARRABBA'S, L.L.C.

FIRST: The date of filing of the Articles of Organization was February 27, 2004.

SECOND: Article II of the Company's Articles of Organization is hereby deleted in its entirety and replaced with the following:

**ARTICLE II**  
**NAME AND PRINCIPAL PLACE OF BUSINESS**
