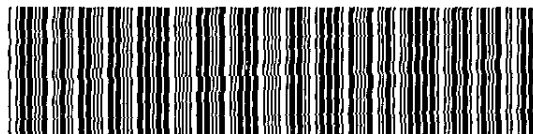


Article V. Management
