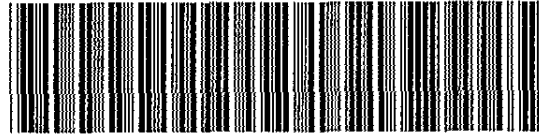

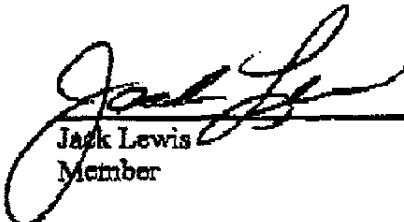
1. The name of the Limited Liability Company: A & J ASSET MANAGEMENT, L.L.C.

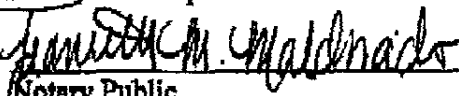
