THE SERVICE ON THE SERVICE OF THE SE The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

## ARTICLE I -- NAME

The name of the limited liability company shall be Northern Tile and Marble, L.L.C.

## ARTICLE II -- ADDRESS
