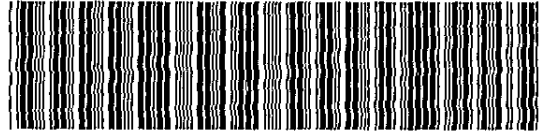


#### **Article V. Management**
