ARTICLES OF ORGANIZATION
FOR
WESTSIDE TREE SERVICE, LLC

The undersigned, the organizing Member of a Limited Liability Company to be formed under the Florida Limited Liability Company Act, as Amended (the "Act"), hereby forms a Florida Limited Liability Company (the "Company") pursuant to the Act, and hereby set forth the following Articles of Organization (the "Articles"):

ARTICLE I

Name

The name of the Company is WESTSIDE TREE SERVICE, LLC.

ARTICLE II

Commencement Date and Duration

The Company's existence shall commence on the date these Articles are filed with the Florida Department of State, and shall continue perpetually until dissolved in accordance with Section 608.441 of the Act.

ARTICLE III

Purpose

The Company is created for purposes of engaging in any lawful activity deemed appropriate by the member from time to time.

ARTICLE IV

Principal Office

The mailing address and street address of the principal office of the Company shall be 920 - 36th Street West, Bradenton, Florida 34205.

ARTICLE V

Registered Agent and Office

The initial registered agent for the Company shall be JAMES C. DeBONA, and the address of the registered agent for service of process shall be 920 - 36th Street West, Bradenton, Florida 34205.

ARTICLE VI

Management of Business

The Company shall be Member managed.

ARTICLE VII

Powers

The Company shall have all of the powers and authority set forth in Section 608.404 of the Act.

ARTICLE VIII

Operating Agreement

An Operating Agreement shall be prepared and adopted to govern the internal affairs of the Company containing such provisions as may be necessary, reasonable, or desirable, except that no provision of such Operating Agreement may conflict with the provisions of these Articles unless permitted herein. The power to adopt, alter, amend, or repeal the Operating Agreement shall be set forth in the Operating Agreement.


