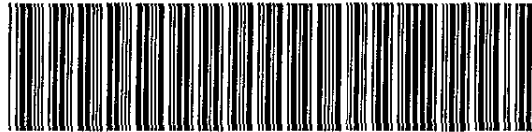



The undersigned, desiring to form a limited liability company under the provisions of Section 608.401 Florida Limited Liability Company Act, as amended, hereby sets forth the following:

Article I Name. The name of the Limited Liability company is Stonewall Fabrication , LLC.

Article III Registered Office and Agent. 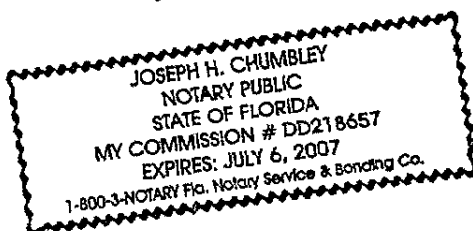


