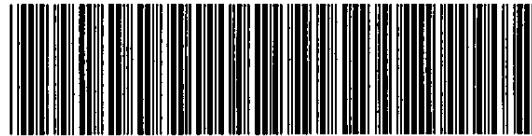


FIRST: The Articles of Organization were filed on March 3, 2004 and assigned document number L04000016953.
