The name of the Limited Liability Company is LEIBOWITZ BROADCASTING LLC (the "Company").


ARTICLE II - Address

The mailing address and street address of the principal office of the Company is One SE Third Avenue, Suite 1450, Miami, Florida 33131.


ARTICLE III - Registered Agent
