These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

2. Duration. The latest date upon which the limited liability company is to dissolve is January 1, 2044.

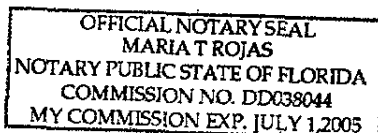
