**ARTICLES OF AMENDMENT OF
ARTICLES OF ORGANIZATION OF

The undersigned, for the purpose of amending the Articles of Organization of Vision Fuel Services, LLC, a limited liability company formed and existing under the laws of the State of Florida, adopts the following Articles of Amendment pursuant to Section 608.411, Florida Statutes:

ARTICLE I - NAME
