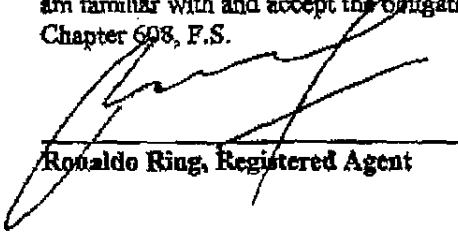

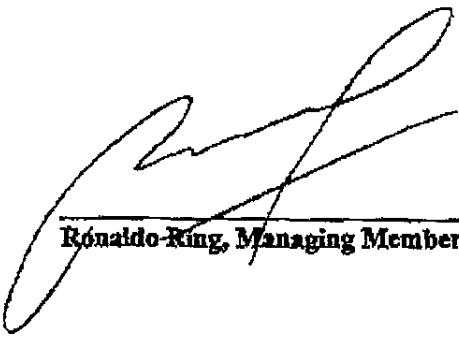
ARTICLE VIII - TRANSFERABILITY OF MEMBER'S INTEREST

No member shall have the right to assign the member's interest in the company without the written agreement of the majority of the units.
