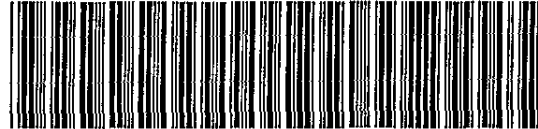




ARTICLE V - ADMISSION OF ADDITIONAL MEMBERS

ARTICLE VI - MEMBERS RIGHTS TO CONTINUE BUSINESS


In the event of the death, retirement, resignation, expulsion, or bankruptcy of a member or the occurrence of any other event which terminates the continued membership of a member in the


