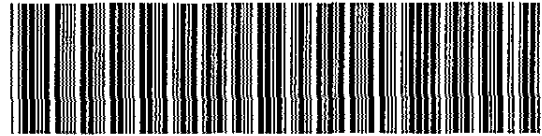

ARTICLES OF ORGANIZATION FOR SAVEONWARRANTY.COM, LLC

Article 1

The name of the limited liability company is **SAVEONWARRANTY.COM, LLC** ("Company"). The Company is hereby empowered to engage in all business and activities lawful under the laws of the United States of America and the State of Florida.
