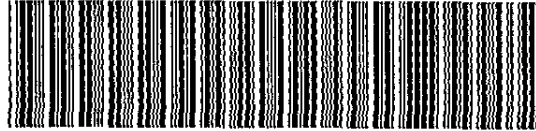

ARTICLE I - NAME


The name of this limited liability company is STOCKROOMSURPLUS, LLC (the "Company").


