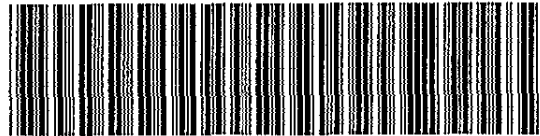

ARTICLES OF ORGANIZATION
OF
C AND H PROPERTIES AND INVESTMENTS, L.L.C.

Article I. Name

The name of this limited liability company is C and H Properties and Investments, L.L.C. ("the Company").

Article II. Duration

The duration of the Company shall be perpetual.

Article III. Address of Principal Office

Article IV. Initial Registered Agent and Address

No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and upon such terms and conditions as shall be determined by all the members. Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or upon the occurrence of any other event that terminates the continued membership of a member in the Company, the remaining members of the Company shall have the right to continue the business of the Company, provided that all remaining members consent to the continuation and there is at least one remaining member.


