CARGOR PARTNERS VI - BUCKEYE 928 LC


FIRST: Articles of Organization for Cargor Partners VI - Buckeye 928 LC ("Company") were filed on March 5, 2004 and assigned Document Number L04000017679. Article I of the Articles of Organization were amended by the Company's members and filed on March 29, 2004 under Document Number L04000017679. Article VI of the Articles of Organization were amended by the Company's members and filed on May 25, 2004 under Document Number L04000017679 (collectively all of the foregoing are the "Articles").

SECOND: The following amendment to the Articles was adopted by the Members of the Company:

Article IV of the Articles are deleted and replaced with the following:

The Company shall be Member Managed and the Members may appoint a Manager pursuant to a written agreement among the Members ("Operating Agreement"). Upon the date hereof, the Members have appointed BUCKEYE MANAGER, INC., a Florida corporation, a Manager to serve subject to the requirements of the Operating Agreement, and subject to removal and replacement as provided therein..
