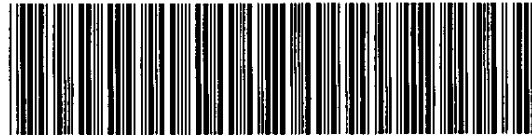

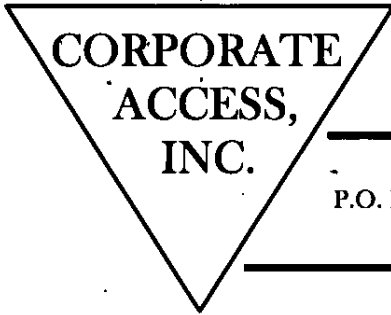

1. Name. The name of the limited liability company is CU Housing Partners, LLC, a Florida limited liability company (the "Company").
