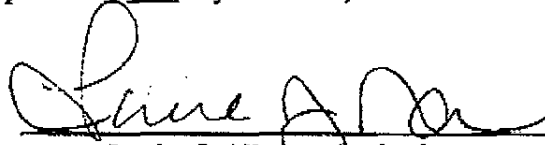
ARTICLE VII

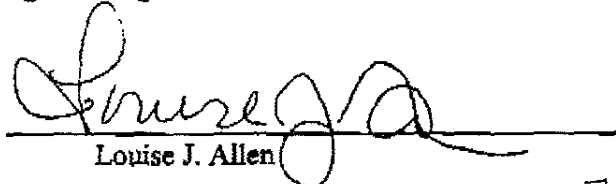
