The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I - NAME:**

The name of the Limited Liability Company is: SPACE COAST THOROUGHBREDS, LLC ("Company").

#### ARTICLE V - ADMISSION OF NEW MEMBERS

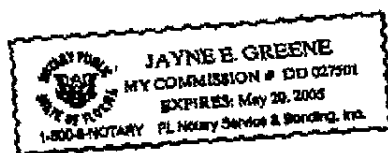


