ARTICLES OF ORGANIZATION FOR ELMO INVESTMENTS, L.L.C.

ARTICLE I - NAME

ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS

The members of the Limited Liability Company shall be permitted to admit additional members upon approval of members owning all the issued and outstanding Member Units of the Limited Liability Company. ARTICLE IX - DISTRIBUTION

Notwithstanding the foregoing, the Board of Managers and all of the members may consent to a distribution.
