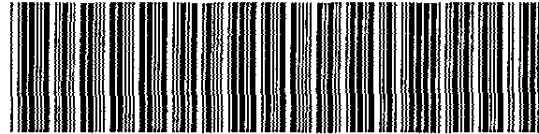

ARTICLE I: NAME

The name of this limited liability company is R & R MARINE, LLC (hereinafter "Company"), whose mailing address and street address of the principal office of the limited liability company is **300 Admirals Cove Blvd., Jupiter, Florida 33477**

ARTICLE II: DURATION

This limited liability company shall remain in existence perpetually; and the effective date of commencement is hereby designated as the date of filing of these Articles.


ARTICLE VIII: ADDITIONAL MEMBERS




